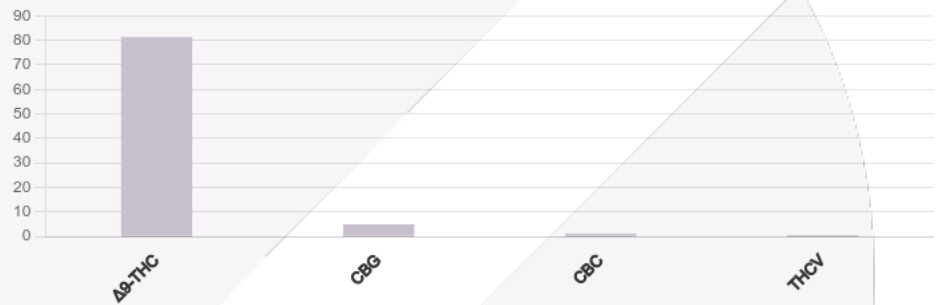
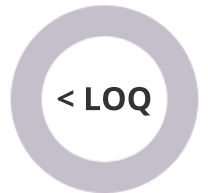
TOTAL CANNABINOIDS

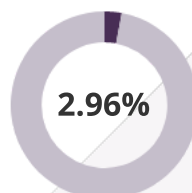
